Health plan selection by people with mobility impairments (PWMIs)



PWMIs

- Little information, choice of health plans and physicians
- Desire information about
 - Benefits**
 - Provider panels**
 - Accessibility issues**
 - Grievance and appeals process**

Why focus on PWMIs?



- Over 12 million adults 18 to 64 have activity limitations
- PWMIs have a thin margin of health
- Increasing numbers of PWMIs are being offered complex choices about health care but have little information to support decision-making.

Who are PWMIs? How to identify?



- **Developed a screener to identify PWMIs**
- **Cognitively tested screener items**
- **Field-tested the items via MassHealth Survey**
- **Revised screener items based on field test results**

Who will use survey and why?



- **CMS/state level purchasing decisions for Medicare and Medicaid**
- **Identify areas where plans need to improve quality of health care services for PWMIs**
- **Provide information to this population before they select a health plan**

What do PWMIs want/need to know?



- **Formed TEP Fall 2005 to develop work plan and benefit from expertise**
- **Published Call for Measures to solicit input**
- **Performed literature review**

- **Current general health & disability status**
- **Health plan interactions**
- **Providing access to needed services**
- **Providing physical access**
- **Provider communication**
- **Preventive health care options**
- **Global ratings**
- **Prescription medications**
- **Demographic information**
- **Assistance completing the survey**

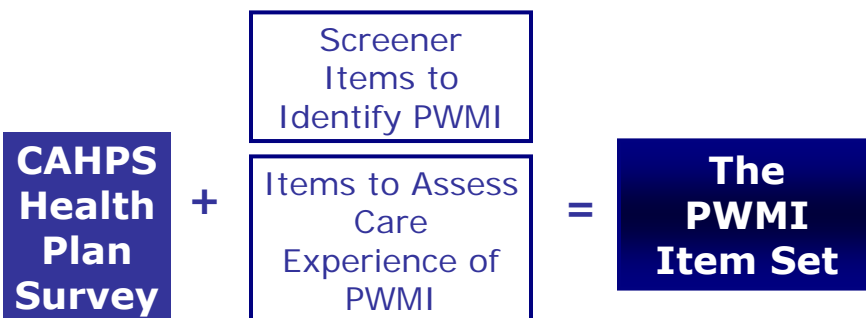
WI field test opportunity
